

THIS LICENSE AGREEMENT is made on **Sat, 29 Jul 2017 02:27:04 -0400** ("Effective Date") by and between **John Doe** (hereinafter referred to as the "Licensee") also, if applicable, professionally known as **John Doe Music**, and **Christopher Summers (DJ iShine)** (hereinafter referred to as the "Licensor"). Licensor warrants that it controls the mechanical rights in and to the copyrighted musical work entitled **The Beat Title (Contract Preview Only)** ("Composition") as of and prior to the date first written above. The Composition, including the music thereof, was composed by **Christopher Summers (DJ iShine)** ("Songwriter") managed under the Licensor.

All licenses are non-refundable and non-transferable.

[If you are going to participate in our monthly subscription, please know you cannot get a refund after receiving a beat from us for that month, after 24 hours post purchase and per this agreement, your subscription will last up to 3 months as an initial grace period. To opt out of the 3 month grace period, please inquire about our annual plan. You can cancel your plan at anytime before the 24 hours of purchase within that month.]

WAV, Tracked Out Stems, and Publishing Rights will be delivered within 24 hours for Exclusive Licenses. Licensor may need an extension if it is a holiday weekend; regardless these things will be delivered.

Master Use.

The Licensor hereby grants to Licensee an exclusive license (this "License") to record vocal synchronization to the Composition partly or in its entirety and substantially in its original form ("Master Recording")

Mechanical Rights.

The Licensor hereby grants to Licensee an exclusive license to use Master Recording in the reproduction, duplication, manufacture, and distribution of phonograph records, cassette tapes, compact disk, digital downloads, other miscellaneous audio and digital recordings, and any lifts and versions thereof (collectively, the "Recordings", and individually, a "Recording") worldwide for unlimited copies of such Recordings or any combination of such Recordings, condition upon the payment to the Licensor a sum of **One Thousand, Four Hundred And Ninety-nine Point Ninety-nine US Dollars (\$1499.99)**, receipt of which is confirmed. Additionally licensee shall be permitted to distribute unlimited internet downloads for non-profit and non-commercial use.

Performance Rights.

The Licensor here by grants to Licensee an exclusive license to use the Master Recording in unlimited for-profit performances, shows, or concerts.

Broadcast Rights.

The Licensor hereby grants to Licensee an exclusive license to broadcast or air the Master Recording in unlimited amounts of radio stations.

Credit.

Licensee shall acknowledge the original authorship of the Composition appropriately and reasonably in all media and performance formats under the name "**Christopher Summers (DJ iShine)**" in writing where possible and vocally otherwise. Licensee is responsible for clearing the samples in the music if Licensee purchases a sampled beat from Licensor. Licensor will tell Licensee the sample used for the beat.

Synchronization.

Licensee may exploit and monetize from licensee's unique derived work(s) of composition for use on TV, Film, Video game or other synchronous projects. Licensee may represent other publishing owners of the original composition for exploitation and have full authority of granting non-exclusive license for synchronization use as long as credit and publishing information is provided to such agency.

Consideration.

In consideration for the rights granted under this agreement, Licensee shall pay to licensor the sum of **One Thousand, Four Hundred And Ninety-nine Point Ninety-nine** US dollars (**\$1499.99**) and other good and valuable consideration, payable to "**Christopher Summers (DJ iShine)**", receipt of which is hereby acknowledged. If the Licensee fails to account to the Licensor, timely complete the payments provided for hereunder, or perform its other obligations hereunder, including having insufficient bank balance, the licensor shall have the right to terminate License upon written notice to the Licensee. Such termination shall render the recording, manufacture and/or distribution of Recordings for which monies have not been paid subject to and actionable infringements under applicable law, including, without limitation, the United States Copyright Act, as amended.

Delivery.

Licensee understands upon purchasing the exclusive license of the instrumental that they will receive the WAV and Tracked Out Stems within 24 hours post-purchasing. Please contact Licensor if you do not get your supplemental audios within that time period. Licensee understands that the follow beat purchased may be on distribution sites such as iTunes and Spotify. The beat is being used only for promotional purposes only for Doing Justice iShine LLC and it has not/will not be sold exclusively to anyone else.

Indemnification.

Accordingly, Licensee agrees to indemnify and hold Licensor harmless from and against any and all claims, losses, damages, costs, expenses, including, without limitation, reasonable attorney's fees, arising of or resulting from a claimed breach of any of Licensee's representations, warranties or agreements hereunder.

Audio Samples.

3rd party sample clearance is the responsibility of the licensee.

Miscellaneous.

This license is non-transferable and is limited to the Composition specified above. Licensor may still have promotional emails in marketing sequence concerning composition. Licensee understands that Licensor has disabled all purchasing and audio links for this composition therefore consumers under licensor will not be eligible to listen to composition once it has been purchased by licensee.

Governing Law.

This License is governed by and shall be construed under the law of the Ohio United States of America, without regard to the conflicts of laws principles thereof.
